

WIGWAM ESCAPE: Code of Conduct and Waiver

In consideration for being permitted to use our **Wigwam Escape** room and related activities (collectively, “activities”) managed by the Institute for American Indian Studies (IAIS), at 38 Curtis Road, Washington, CT 06793, I WAIVE, RELEASE, and DISCHARGE IAIS, its Trustees, officers, directors, employees, members, agents, assigns, legal representatives and successors, and all business associates and partners involved in the presentation of the above noted activity and each of their owners, officers and employees, from all liability for or by reason of any damage, loss or injury to person and property, even injury resulting in the death of the Participant, which has been or may be sustained in consequence of the Participant’s participation in the Escape room activity, and notwithstanding that such damage, loss or injury may have been cause solely or party by the negligence of IAIS.

I understand that, being permitted to participate in the Wigwam Escape room, there are potential risks including but not limited to:

1. Being enclosed in a room with up to 8 people.
2. Mental stress and similar disorders from participation in the game.
3. The use of simple tools and objects that may have been used by Natives in the past and includes a sample spear, small stick and other game parts.
4. Lighting in the room will include dawn and dusk levels of darkness.

I acknowledge that while I am participating in the above noted activity, I will be monitored by video camera and may be photographed after participating in the activity described above. I hereby consent to give IAIS permission to allow my photograph to be displayed, published, or distributed on the IAIS or Wigwam Escape website, the IAIS / or Wigwam Escape Facebook page, and/or any other social media avenues utilized by IAIS.

- I acknowledge that I am liable for intentionally damaging any items at IAIS.
- I acknowledge that I will not be allowed to bring a handheld device, a watch (or other timepiece) while in the Wigwam Escape room in order to take photos or videos or use as a timer while participating in the activity described above.
- I will not disclose the IAIS puzzles, solutions, or other intellectual property related to the Wigwam Escape room to other parties.
- I acknowledge that I am at least 18 years old. (If the participant is under 18 years old, a Parent/Guardian must sign this Contract.) If the participant is under 12, a parent or guardian must remain in the puzzle room during the activity.

I ACKNOWLEDGE THAT I HAVE READ THIS DOCUMENT AND I FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AS WELL AS A CONTRACT BETWEEN MYSELF AND IAIS AND SIGN IT OF MY OWN FREE WILL.
